SPECIAL RENTAL CONDITIONS

REGISTRATION:

All rentals are nominative and can in no case be transferred or sublet. The management will only be committed to the tenant once it has received the application form signed by the latter with the deposit representing **50% of the amount of the stay**, including **administration costs**. **The balance of the stay is payable on arrival.**

Payment methods: credit card/MasterCard, cash, ANCV holiday vouchers.

Bank cheques are reserved for advance payments only.

HOME:

Mobile homes are rented from Saturday to Saturday during the school holidays of July and August.

Outside these periods, the duration is free according to availability.

For all rentals, the possession of the mobile home will be **between 4pm and 7pm**.

On the day of departure, it must be vacated **by 10:00 a.m. in season**.

RATES :

Our rates include : the rental of the mobile home, the consumption of water, gas and electricity, the dishes, bedding (blankets, mattress protectors, pillows, except linen - possibility to rent sheets).

CAUTIONS:

On your arrival, **two** deposits will be required: one of **250 €** to guarantee any damage of all equipment included in the Mobile Home and in the campsite, as well as the access badge; and a **50 €** for the impeccable cleanliness of the mobile home (including the dishes).

Warning : No smoking inside the Mobil-Home.

INVENTORY:

The tenant will make himself the inventory of fixtures (furniture, equipment and kitchen utensils) on his arrival and will return it **the same day** by notifying any anomaly noted. After this period, it will no longer be taken into account.

On the day of your departure, it will be possible for you to take the **Cleaning Package -without dishes- (35€ or 50€)**

The inventory of fixtures will be done on the day of departure by the operator. The deposit will be returned after control and handing over of the keys, after deduction of the possible expenses of replacement of the missing or deteriorated material, of the badly done cleaning and of the loss of the badge. In case of early departure without notice, **the deposit will be retained by the campsite**.

RULES OF PROCEDURE :

Between 10 p.m. and 8 a.m., cars are not allowed inside the campsite, and access is by code.

For everyone's sake, noise should be kept to a minimum between 10 p.m. and 8 a.m.

Inside the enclosure the speed is **strictly limited to 10 Km/hour. Beware of pedestrians!**

Visitors are accepted after agreement of the management and under certain conditions. They are requested to leave their vehicle outside the campsite and to report to the reception. **They will be under the full responsibility of the tenant.**

The selective sorting is compulsory, you will be informed at the reception of the procedure to follow.

We accept small, non-hazardous pets (categories 1 and 2 prohibited and refused) in the rental provided that they observe the basic rules of hygiene (needs done outside the campsite and collected by their owner). They must not be left alone in or around the campsite, must be kept on a leash, tattooed and vaccinated. Please bring their health booklet with you. An animal park located below the campsite is a private property and access is forbidden. It is also forbidden to feed the animals.

SWIMMING POOL :

As the swimming area is **not supervised**, children are under the responsibility of their parents. The management declines all responsibility in case of accident.

The access to the swimming pool is exclusively reserved to the customers of the campsite.

CANCELLATION:

In case of cancellation more than 45 days before the planned date of the rental, the deposit will be refunded except for a 40 € deduction for administrative costs; from 45 days to 15 days before your arrival, the deposit will not be refunded. Less than 15 days before the scheduled rental date, the entire amount of the rental will be due (*you should take out cancellation insurance with your insurer for your stay*).

MEDIATION :

In accordance with Article L. 612-1 of the Consumer Code, within one year of his written complaint, the consumer, subject to Article L.152-2 of the Consumer Code, has the option of submitting a request for an amicable resolution by mediation, to:
